Activities to Date

Preparation of flags began in January of 2021. Covid made the preparation a bit difficult in the early months of the school year. A portion of the supplies were ordered in January of 2021.

On January 19, Phary Om (the new middle school art teacher) and I met to discuss bringing the middle school students into the project in regards to the photographs and the flag projects. Phary will be heading up this endeavor in the middle school. Covid restrictions have prevented me from visiting to do the photography. In early February, I provided white boards, backdrop paper and markers to Phary for use in the photography portion. She is working with her principal to move this forward.

By February 12, we had 1600 flags sewn and ready. Both teachers and community members helped with the sewing. We pushed out 1200 flags as of the first week February. Flags went to teachers and students at EC Best, Northside Early Learning Center, Churchill County Middle School and Churchill County High School.

Additionally, flags were dropped off in prepackaged kits to the Churchill County Library for community members. Kits include an instruction sheet (see attached), two Sharpie markers and a flag. Community members can stop by the library and request a flag kit. They can then drop off the kit in the book drop.

The Churchill County Library has offered additional support of the project by promoting it on their website and social media outlets. Joe Salsman assisted me in creating a video clip that describes the project and invites people to come participate. This was shared via their website, social media and the #WhyYouMatterFallon social media sites also. The Churchill county Library has also placed an informational banner on their website to help promote the project.

To date, 100 flags have been returned completed and are being prepared for display.

I have been in touch with Lucy Calahan and Robyn Jordan in order to arrange for display of the flags in the community.

I have created a Google Form in order to collect data regarding the participants. These forms were shared with teachers to date. I will be posting a form for community members to share their information as well.

Year 2: #WhyYouMatter Positive Intention Flags








Thank you for being a part of this community wide art project! We invite you and your family members to make your own individual flag.

When you finish creating your flag, please place it back in the bag with the markers (if you borrowed markers) and return it to the Churchill County Library or to Ms. Shafer at the Churchill County High School. Place your name on the back along with your phone number if you would like your flag returned to you.

***Students and classroom teachers please remember to write the student name, classroom or teacher name and the school on the back so that the flags may be returned after the display comes down.



Directions:

Create a positive message or drawing on one side of the flag using permanent markers. You are welcome to use other materials such as acrylic paint if you have it. Anything that is permanent will work.

Please keep your message positive and uplifting. It could be a poem, a quote, a drawing, etc.

Allow your work to dry (if you are using something other than the Sharpie) and be sure to put your name on it somewhere (on the corner or on the fold on the back). Remember, Sharpie markers will bleed through the canvas so be aware of that when you put your name on it.

Eventually, the flags will all be strung together and displayed in our community. More information to come on the display.
